Meetings

Excessive absenteeism may result in disciplinary action and may include temporary forfeiture of membership privileges or permanent expulsion from the Club.

Other

All newly elected members are subject to a two (2) Year probationary period. At the completion of each year, the membership will hold a discussion on the membership status of the probationary member which will be followed by a vote of confidence. Probationary Members not gaining a majority of member's votes at the end of either probationary year will be expelled from the Club.
